Dear Colleagues,

The Department of Health have sanctioned the creation of the following grades which are to be used to both accurately record and report this staff cohort and for the purposes of subsequent financial allocation, specifically related to this cadre of staff.

Emergency Medical Technician: In respect of the establishment of a new EMT grade, the Department of Health sanctions a red circling arrangement in respect of pay, strictly on a personal to post holder basis for NAS employees currently on grade code 6132, who are in receipt of a higher rate of pay than that which is sanctioned for this grade. However, that cohort of NAS employees, as well as NAS employees coded to 6133 and 413y must be recoded to the new EMT code when it is established.

Paramedic: The Department understands that Paramedics are currently coded to the existing EMT grade (code 6463) which is an 11pt pay scale. This new Paramedic pay scale has been creating by dropping the first point of existing EMT 6463, resulting in a shortened 10pt pay scale. In migrating to Paramedic 3195, no existing Paramedic will experience any change to their rate of pay. Any guidance that issues from the HSE in respect of the new Paramedic grade must clearly set this out. On qualification and taking up post, all new Paramedics appointed to 3195 will commence on point 1 of the new Paramedic 10pt scale.

Student Paramedic: In recognition of challenges to the recruitment of this grade, the Department of Health sanctions the red circling of existing pay for any suitable Health Service employee who may wish to retrain to become a Paramedic, strictly on a personal to holder basis for the duration of the Student Paramedic training. The grade of EMT Student (code 6453), must be made obsolete without delay, and all existing employees recoded as appropriate.

To note for SAP sites, confirmation has been received from SAP Centre of Excellence that the new grade codes are now available for use on SAP.
